INTRODUCING CONVERSATIONS

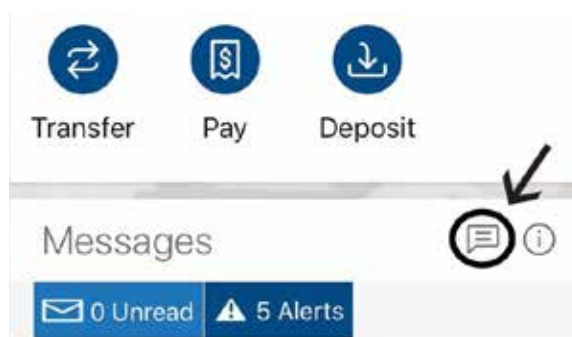

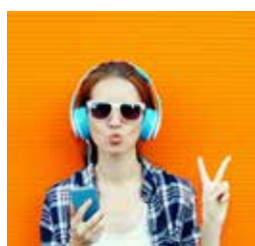
